Code of Conduct

Participants, as well as spectators, are expected to follow the Code of Conduct whenever using the Center facility. These policies apply to the center property in its entirety.

1. All participants will agree to have a photo taken for a MSCC ID card. Swipe ID card when entering and leaving. You are required to enter and leave by the front door.
2. Treat everyone with respect, including other participants, spectators and MSCC volunteer/staff.
3. Use appropriate language—no cursing.
4. Running in the building is not permitted unless participating in a gym activity.
5. Share equipment and materials with others. Take care of the equipment you use.
6. Clean up any spills or messes that you create. Ask for help if needed.
7. Report anything broken to the receptionist or to an MSCC volunteer/staff member.
8. Any changes to TV, CD, DVD must be approved by a volunteer/staff.
9. No fighting or verbal abuse will be tolerated*

***If you fight or verbally abuse another participant, spectator or volunteer/ staff member, you will be asked to leave the center, and will not be permitted to return for a week, at the discretion of the program leader. If you are a minor age 17 or under, your parent/guardian may be called to pick you up from the center.**

Other policies:

1. Game room door will remain open during use of room.
2. All participants will have a medical consent form and permission/waiver form on file.
3. No **open** drink containers or food is allowed in the gym. Bottled drinks with a cap in place may be kept on the sideline of the gym.
4. No shoes with any type of roller wheels are permitted in the building.

MSCC volunteers and program leaders have the authority to enforce this Code of Conduct at their discretion.
